The Georgia Board of Health Care Workforce (GBHCW) strives to identify the physician, physician assistant, advanced practice, registered nurse, and dentist workforce needs of Georgia communities, and to meet those needs through the support and development of medical education programs.

The Georgia Board of Health Care Workforce (Board) members and staff are pleased to present the Award Report for Loan Repayment Programs for the Fiscal Year 2022.

In total, the Board awarded <u>\$1,782,247</u> to 94 recipients:

- Physicians for Rural Areas Assistance Program, 36 recipients, 24 counties, \$921,283
- Georgia Physician Loan Repayment Program, 4 recipients, 4 counties, \$170,000
- Dentists for Rural Areas Assistance Program, 12 recipients, 9 counties, \$271,137
- Physician Assistant Loan Repayment Program, 21 recipients, 17 counties, \$210,000
- Advanced Practice Registered Nurse Loan Repayment Program, 21 recipients, 14 counties, \$209,827

These programs require a commitment to practice for a minimum of 40 hours per week in a Georgia county with a population of 50,000 or less people according to the 2020 Census Count of the United States Bureau of the Census. The practice time requirement can be split between two or more counties, provided that none of the practice location counties exceed the 50,000 population limit, unless approved by the Board.

The administrative costs to carry out these loan repayment programs are funded through the Board Administration program of the Georgia Department of Community Health section in the state's budget, while the awards were funded through the Physicians for Rural Areas Assistance program.



In FY 2022, the Board awarded 36 recipients through the Physicians for Rural Areas Assistance program which provided 24 rural Georgia counties with improved access to care.




The Georgia Physician Loan Repayment Program (GPLRP) is a program funded by the State of Georgia and a grant from the Health Resources and Services Administration (U.S. Department of Health and Human Services) that provides a service-cancelable loan of up to \$25,000 per year for a two-year period. It is limited to physicians and aimed at those physicians practicing the specialties of family medicine, internal medicine, pediatrics, OB/GYN, geriatrics or psychiatry in a Health Professional Shortage Area located in a qualifying county. The participant may elect to re-apply for additional funding to be awarded on an annual basis for two additional years for a maximum of four years and \$100,000. In FY 2022, the Board awarded four recipients through the Georgia Physician Loan Repayment Program which provided four rural Georgia counties with improved access to care.



In FY 2022, the Board awarded 12 recipients through the Dentists for Rural Areas Assistance program which provided 9 rural Georgia counties with improved access to care.



In FY 2022, the Board awarded 21 recipients through the Physician Assistant Loan Repayment Program which provided 17 rural Georgia counties with improved access to care.


