Approval of Agenda

Dr. McFadden presented the agenda for the meeting to the Board for approval.

On Motion, Barber/Rios, the Board unanimously approved the agenda for the January 20, 2022 meeting.

Approval of Minutes

Mr. Kemp presented the minutes from the October 21, 2021 meeting for review and approval.

On Motion, Rios/Indrakrishnan, the Board unanimously approved the minutes of the October 21, 2021 meeting.

Introductions

Freeman Montaque conducted a roll call of board members (including those new to the Board), staff, and guests.

Chairperson's Report

Dr. McFadden conducted the swearing-in of new board member James L. Smith, Jr., MD.

Dr. McFadden spoke regarding the untimely death of LaSharn Hughes in October 2021. She honored LaSharn by reading her obituary and speaking of her dedication to serving the state. She said LaSharn impacted many lives during her career and she will be greatly missed. Dr. McFadden thanked Mr. Montaque for stepping in as Interim Executive Director and Ms. Tucker for coming back to help as needed.

Dr. McFadden welcomed new board members and stated virtual meetings will continue until which time it is safe to resume face-to-face meetings. She informed the Board the April meeting is moved to April 28th. She also updated the board on the search for a new Executive Director. Finally, she spoke of the need to hold a board retreat in-person as soon as it is safe to do so.

Interim Executive Director's Report

Mr. Montaque thanked Dr. McFadden for the wonderful tribute to Ms. Hughes. He informed the Board that staff is still mostly teleworking. He introduced the new External Affairs Coordinator, Aybriel Beckham.

Mr. Montaque presented the idea of honoring LaSharn Hughes by naming the conference room after her and having a plaque and portrait placed in her honor. The Georgia Board of Health Care Workforce, Georgia Composite Medical Board, and the Pharmacy and Dentistry Boards agree with this idea.

Governor's Budget Recommendations AFY 2022 & FY2023

Mr. Montaque reviewed the Governor's budget recommendations for Amended Fiscal Year 2022 and Fiscal Year 2023. For AFY2022, the Governor is recommending an increase in funds of \$24,234 in the Board's Administration budget to provide for a \$5,000 pay increase for all full-time, benefit eligible state employees to address agency recruitment and retention needs. This is a statewide recommendation for eligible state employees. That is the only recommendation in the Amended Budget.

For Fiscal Year 2023, the Governor has made the following recommendations:

Administration: \$66,521

- Increase funds to provide a \$5,000 cost-of-living adjustment for all full-time, benefit-eligible state employees, effective July 1, 2022, to address agency recruitment and retention needs \$33,623
- Increase funds to allow eligible state employees to withdraw up to 40 hours of earned annual leave annually from their accrued leave balance \$2,549
- Reflect a change in the Employees' Retirement System employer contribution rate to fully fund the actuarial determined employer contribution, provide for a cost-of-living adjustment for retirees, increase the employer 401(k) match for Georgia State Employees' Pension and Savings Plan (GSEPS) employees, and fund the employer share of accrued forfeited leave for retiring employees \$30,349

Graduate Medical Education: \$3,626,327

- Increase funds to reflect an adjustment in the Federal Medical Assistance Percentage (FMAP) from 66.85% to 66.02%. \$411,342
- Increase funds for 136 new residency slots in primary care medicine. \$2,534,985
- Increase funds for a pilot program to perform echocardiograms of pregnant and postpartum women to address maternal mortality. \$680,000

Mercer School of Medicine Grant: \$1,073,231

• Increase funds for the third year of the seven-year plan for Mercer School of Medicine's medical school campus in Columbus. State General Funds - \$1,073,231

There was discussion among Board members regarding the pilot program recommendation. Dr. Barber stated no one objects to the pilot program, but he was just unsure if it belongs under the GBHCW budget, as the Board is not currently staffed for oversight of such a program. Dr. Rios agreed with Dr. Barber's concerns, stating if it remains in the Board's budget, other programs may come our way that do not follow the Board's mission.

Mr. Montaque reviewed the budget process and reminded the Board it is just the beginning of the legislative session and these recommendations may stay and/or change as the budget moves through the House and Senate recommendations.

Loan Repayment

Ms. Speight presented the list of loan repayment applicants for the FY2022 cycle:

On Motion (Rios/Kemp), the Board unanimously voted to approve the PRAA loan repayment awards as presented.

Dr. Barber informed the Board a lot of time was spent going over the formula used for ranking applicants and the current formula works. The problem is lack of funds available for all qualifying applicants.

Repayment Requests

Mr. Montaque summarized the requests of 3 scholarship recipients:

Leila Borders, MD

Dr. Borders defaulted on her scholarship obligation and is required, by contract, to repay \$240,000. She has repaid over half of the amount and is requesting once she reaches the \$160,000 mark to a) have the remaining \$80,000 forgiven or b) could she give her monthly payment directly to Mercer University to support their Primary Care Accelerated Track Program.

The Board members had a lengthy discussion regarding the proposals and ultimately agreed they have to follow the contracts.

On Motion (Barber/Rios), the Board unanimously agreed to deny both of Dr. Border's requests and she is required to pay her remaining balance of \$80,000 to the Board.

Matthew Pearce, MD

Dr. Pearce has submitted a payment proposal for the Board's review. His proposal is to repay his obligation of \$160,000 quarterly over an 8-year period by paying \$5,000 per quarter beginning September 1, 2022. Payments will be due on March 1st, June 1st, September 1st and December 1st throughout the payment period. At the end of the 32 payments his obligation to the GBHCW will be fulfilled.

Dr. Rios reminded the Board that recipients know going into a fellowship it may be harder to find a rural practice and could impact their contract obligation.

On Motion (Rios/Barber), the Board voted unanimously to accept Dr. Pearce's repayment proposal as presented to repay his obligation over eight years at \$5,000 per quarter, beginning September 1, 2022.

Josephine Pearson, MD

Dr. Pearson has been repaying her scholarship default through a promissory note initiated by the Attorney General's office in 2017. She is requesting the Board either consider forgiving her loan repayment, or reduce the amount owed due to falling on hardships from COVID-19.

Ms. Harris, from the Attorney General's office, stated if the Board were to entertain restructuring her payment plan temporarily, there would be no need for a new promissory note. If the Board were to entertain a permanent change to her payment plan, she would be required to sign a new promissory note. Ms. Tucker asked Ms. Harris since Dr. Pearson's file was turned over to the Attorney General's office for collection, should Dr. Pearson's requests be going through her office instead of directly to the Board. After lengthy discussion, the board agreed additional clarity from the Attorney General's office was needed before action could be taken on this request.

On Motion (Barber/Gautney), the Board unanimously voted to postpone action on Dr. Pearson's request to give the Attorney General's office additional time to research the proper steps on collections.

Annual Report

Mr. Montaque gave a brief overview of the Annual Report of the Board. He noted it was the last report completed by Daniel Dorsey and that Ms. Beckham would be completing the report, going forward.

New/Old Business

Dr. McFadden reminded the Board the next meeting would be April 28, 2022, not April 21st as previously published. She asked if members of the Board had any other thoughts on ways to honor LaSharn. Several things were mentioned, including naming a loan repayment program after Ms. Hughes and offering support to staff members. Dr. McFadden appointed an ad-hoc committee to discuss options. Members of the ad-hoc committee are: Mr. Montaque, Dr. Clevenger, Dr. Rios, Ms. Reeves and the Executive Committee.

Dr. Barber wanted to inform the Board there is a bill floating around that would provide funds for rural physicians. It is the same bill from last year: House Bill 42 by Representative Schofield.

Adjournment

On Motion (Barber/Gautney), there being no further business, the Board unanimously moved to adjourn the meeting at 10:20 am.
