Members of the General Assembly, the state's medical community and the general public:

The Georgia Board for Physician Workforce (GBPW) members and staff are pleased to present the Award Report for Loan Repayment Programs for the Fiscal Year 2017. In total, the Board awarded **\$1,446,595.13** to 70 recipients spread across 48 different counties:

- PRAA, 30 recipients, \$750,000
- GPLRP, 12 recipients, \$300,000
- DRAA, 8 recipients, \$200,000
- PALRP, 9 recipients, \$90,000
- APRNLRP, 11 recipients, \$106,595.13

These programs require a commitment to practice for a minimum of 40 clinical hours per week in a Georgia county with a population of 35,000 or less people according to the 2010 Census Count of the United States Bureau of the Census. The practice time requirement can be split between two or more counties, provided that none of the practice location counties exceeds the 35,000 population limit.

The administrative costs to carry out these loan repayment programs are funded through the Board Administration program of the Georgia Department of Community Health section in the state's budget, while the awards were funded through the Physicians for Rural Areas program.

In 2017, the GBPW awarded 30 recipients through the Physicians for Rural Areas Assistance program which provided 24 rural Georgia counties with much-needed access to care.



PRAA (continued)

The Georgia Physician Loan Repayment Program (GPLRP) is a program funded by the State of Georgia and a grant from the U.S. Department of Health and Human Services Health Resources and Services Administration and provides a service -cancelable loan of up to \$25,000 per year for a two-year period. It is limited to physicians and aimed at those physicians practicing the specialties of family medicine, internal medicine, pediatrics, OB/GYN, geriatrics or psychiatry in a Health Professional Shortage Area located in a qualifying county. The participant may elect to re-apply for additional funding to be awarded on an annual basis for two additional years for a maximum of four years and \$100,000. The following individuals were each awarded \$25,000 through the GPLRP for FY 2017 and will receive another \$25,000 in FY 2018.
