

MESSAGE FROM **EXECUTIVE DIRECTOR**

The Georgia Board of Health Care Workforce Board members and staff are pleased to present the Award Report for Loan Repayment Programs and Scholarship Program for the Fiscal Year 2023.

In total, the Board awarded \$2,239,796 to 116 recipients.

The Loan Repayment programs require a commitment to practice for a minimum of 40 hours per week in a Georgia county with a population of 50,000 or less people according to the 2020 Census Count of the United States Bureau of the Census. The practice time requirement can be split between two or more counties, provided that none of the practice location counties exceed the 50,000 population limit, unless approved by the Board.

Beginning in Fiscal Year 2015, funds for Scholarship Program were realigned through the budgetary process to the Physicians for Rural Areas (PRAA) program of the Board. The realignment of funds provided additional loan repayment awards to physicians. Although the final scholarship award was made in FY2018, there are 10 scholarship recipients that are still under the obligation phase. Not included in these numbers is any recipient currently in the deferral, repayment, or default process. All recipients should complete the Scholarship Program and its service obligation in FY2026.

The administrative costs to carry out these loan repayment programs are funded through the Board Administration program of the Georgia Department of Community Health (DCH) section in the state's budget, while the awards were funded through the Physicians for Rural Areas Assistance program.


PHYSICIAN ASSISTANT LOAN REPAYMENT PROGRAM (PALRP)



IMPACT OF APRNLRP

In FY 2023, the Board awarded 45 recipients through the Advanced Practice Registered Nurse Loan Repayment Program which provided 23 rural Georgia counties with improved access to care as indicated in blue.



SCHOLARSHIP PROGRAM (GME)

The Georgia Board of Health Care Workforce Scholarship Program was an annual award for Georgia students who were accepted in an accredited four-year medical school in the U.S. leading to a Doctor of Medicine or Doctor of Osteopathic Medicine degree. This scholarship was designed to furnish \$20,000 in financial aid to deserving medical students who could not afford the cost of medical school while also bringing needed medical attention to smaller, rural counties in Georgia. Upon graduation from medical school and a residency program, recipients must be licensed to practice in Georgia and must practice medicine in a community of 50,000 or less for one year after completing graduate medical education for each year of scholarship funding received. The scholarship was renewable for up to four years for a maximum of \$80,000. No new scholarship awards are being made due to the realignment of funding.


