Practice Opportunity/Medical Fair Update

Mr. Dorsey touched on highlights from the medical fair in August.

The Georgia Board for Physician Workforce co-sponsors "practice opportunity fairs" each year in conjunction with graduate medical education programs to link resident physicians with employment opportunities around the state. Invited participants are resident physicians of Georgia-based GME programs and any hospital or health system recruiting for practice opportunities in Georgia.

In FY 2019, two physician residency programs across the state teamed up with the GBPW to host fairs. Below are total figures and a breakdown of participation at each fair.

Total 50 exhibitors 89 residents 1.8 resident-to-exhibitor ratio
